- Once you sign up for the plan payment, you won't have to write a check for that payment again nor run to the bank to deposit a check for that settlement.
- With direct deposit, you will still receive a complete copy of your grain settlement, but your money will be automatically deposited in your account, normally within two (2) business days after settlement.
- With direct payment, while you will still receive a statement each month, your payment is automatically taken out of your bank account. Each direct payment is deducted from your account on the due date each month, so it is easy to track.
- if you have questions regarding a bill, you still have ample time to call and resolve your concerns.
